- Articles of incorporation of the company;
- A copy of the shareholders' register and supplemental official documents evidencing the name(s), address(es), place(s) of residence and "tax identification"<sup>5</sup> number(s) of all the owner(s) up to the ultimate beneficial owner(s) of the company or the formal name and the "tax identification" number of the company, if the ultimate beneficial owner is a company quoted on the stock exchange;
- Proof of registration with the Chamber of Commerce;
- Copy of business permit *or*
- Proof of business permit application;
- Evidence of the company keeping a bank account with at least one bank established in the Netherlands Antilles *or*
- Evidence of the management of the company being conducted by a Trust office established in the Netherlands Antilles, supervised by the Supervisory Board for trust businesses (***this applies only to companies in the gaming sector***);
- Proof of the tax identification number;
- A statement to the effect that consultations have been started with the customs department (Technical Affairs Department) with regard to the specific customs regulations.
