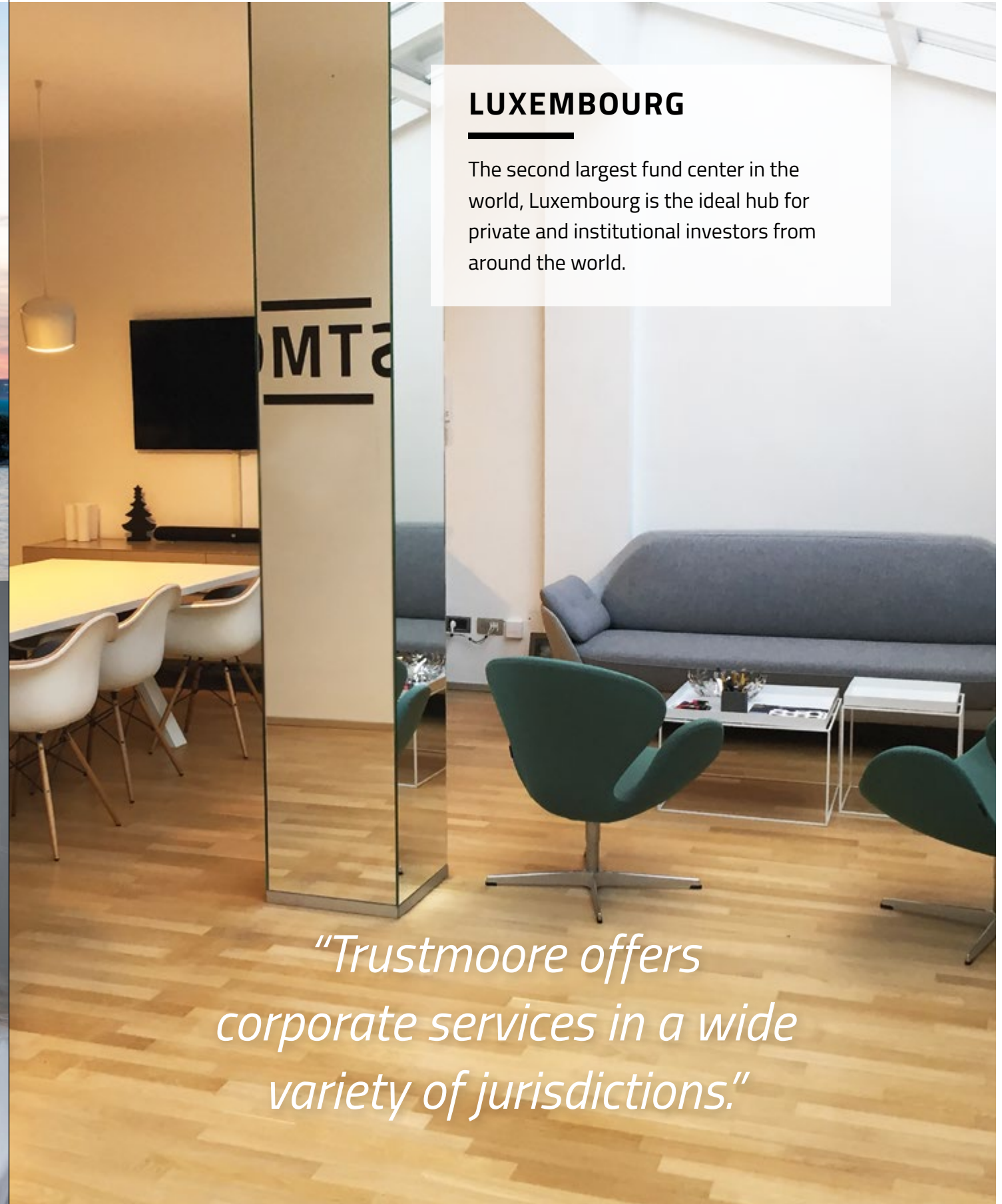


SINGAPORE




